P2 includes:

- two Screening Instruments:
 - *P2B* - a Brief screen designed for unlimited use
 - *P2C* - a Comprehensive screen designed for weekly use or as prescribed
- real-time scoring that calculates risk & prompts immediate relapse prevention interventions

Remotely Monitor → Predict Warning Signs → Intervene → Prevent Relapse

How does P2 Predict Warning Signs?

- Remote screening tools detect & predict early warning signs to produce risk scores
 - Monitors mood, anxiety, sleep and QOL
 - Monitor changes in social determinants of health
 - Aggregates data to inform treatment
- Integrates cloud biometrics device data to inform treatment

How does P2 Prevent Relapse?

- Risk scores immediately trigger interventions
 - Via secure Chat, Counselor contacts client
 - Via secure Chat, Friends/Family contact client
 - Personally supportive content & multi-media sent to client - family photos, videos, music, art
- Interventions interrupt Triggers & Cravings and Prevent Relapse

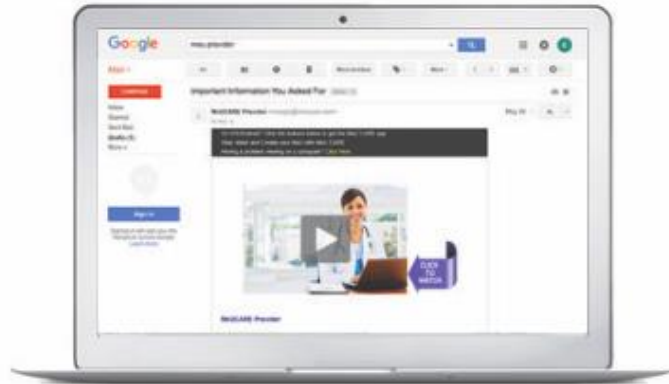
